Cllr Gibbon agreed to represent FTC at the meeting and it was hoped that local objectors would also attend to voice their concerns.

24/34 Planning Applications

1. PA24/03780. Demolition of existing garages. Proposed new garage and workshop with dual pitched roof. 44, Polvillion Road, PL23 1HG. It was proposed by Cllr Patterson, seconded Cllr Gibbon and RESOLVED that a recommendation of no objection should be sent to Cornwall Council, although noting FTC's concerns over the height of the new workshop.

2. PA24/05285. The proposals are to extend the existing single storey extension to the rear of the dwelling. The Old Barn, St Fimbarrus Road, PL23 1JJ.
